About MRT Trainings:	<p>Moral Reconciliation Therapy – MRT® Facilitator Training is 32 hours conducted over 4 consecutive days. A certified CCI-MRT instructor conducts each training on site with visual aids and print materials or as a virtual event via Zoom video conferencing with white board and digital file sharing where all training materials are shipped in advance of training (shipping charges apply). Participants are assigned approximately 4 hours of homework in preparation to facilitate group counseling.</p> <p>Minimum Investment: \$10,200.00 (minimum of 15 participants at \$680.00 each) Maximum Number of Participants: defined by local occupancy law if in person event or 50 participants if digital event</p> <p>Upon completion, attendees are certified to facilitate MRT groups on their own with no term limitation, will receive a certificate of completion, and be eligible to earn CEU's from LSU-Shreveport.</p>
Cost Breakdown:	<p>A minimum of \$10,200.00 in total registration fees (employees and outside registrants, if applicable) must be collected by Correctional Counseling, Inc. at least one month in advance of training date. All additional participants above 15 are billed at \$680 each.</p> <p>For in-person training events, additional ACTUAL expenses will be billed to the Agency to cover travel (flight, rental car, ground transportation, fees, taxes, etc), lodging, and food of the Trainer(s). The additional expenses are <i>estimated</i> to be \$2,500.00. However, if you have to budget a specific amount for expenses, we recommend budgeting \$3,000.00.</p>
Materials:	<p>During the training, each participant will receive the following materials at no additional cost:</p> <ul style="list-style-type: none">• <i>How to Escape Your Prison</i> (the MRT workbook)• <i>MRT Facilitators' Guide</i> (contains information on the group process, specific objective criteria and guidelines for all exercises and tasks of MRT with specific "how to" instructions)• <i>Psychological Reports</i> (reprints of 10 journal articles on outcome data on MRT programs)• <i>Effective Counseling Approaches</i> (description of Cognitive Behavioral approaches, cognitive restructuring, and cognitive skills programs)• Flash Drive/ CD – <i>5 Minute Stress Manager and Imaginary Future</i> (used to instruct facilitators on how to get clients to set appropriate long-term goals)• <i>Antisocial Personality Disorder and Criminal Justice: Evidence Based Practices</i> (contains information on treating clients with most resistance) <p>Agency/Certified MRT Facilitators must purchase an MRT workbook for each client.
